DIRECTIONS FOR USE:

SHAKE WELL BEFORE USE

APPLICATION:

Can be applied by boom spray, aerial spray or fertigation. Water rates will vary according to crop type, growth stage and canopy area.

Pip Fruit: 5L/ha in a minimum of 500L of water. At petal fall 10mm fruitlet size then at 7-10 day intervals until harvest. Post Harvest Dio: Golden Delicious: 0.5L/100L

All other varieties; 2.0L/100L Dip for 60 sec. in dip solution that has similar temperature to fruit and change dip regularly.

Stone Fruit: 5L/ha in a minimum of 500L of water. After flowering then as required to improve fruit firmness and quality.

Berry Fruit: 5L/ha in a minimum of 500L of water. Apply post fruit set at 10-14 day intervals as required.

Strawberries: 5L/ha in a minimum of 500L of water. At 10-14 day intervals during flowering and fruit set.

Tomatoes: 5L/ha in a minimum of 500L of water. After flowering then continue at 10-14 day intervals as required.

Lettuce: 5L/ha in a minimum of 500L of water. Mid growth at first head formation, repeat at 10-14 day intervals as required.

Onions: 5L/ha in a minimum of 500L of water. Apply at bulb formation and repeat at 14 day intervals until harvest.

Carrots: 5L/ha in a minimum of 500L of water. Apply at 15cm crop height.

Potatoes: 5L/ha in a minimum of 500L of water. Every 21 day interval after tuber formation (3-4 applications).

Citrus: 7L/ha in a minimum of 700L of water. 3 Applications 14 days apart. Commence when fruit is marble size.

Bananas - 5L/ha in a minimum of 500L of water. Apply monthly.

When mixing with other liquid fertilizers, test for compatibility with a small quantity in a jar.
